

## **PRIVACY NOTICE**

Zaryab.org (“we” or “us”) is committed to protecting the privacy of the personal data we collect from users of the WaterMate app (“App” or “Service”). This Privacy Notice explains our data privacy practices, including how we collect, use, and protect your personal information.

### **Changes to This Notice**

To ensure we effectively manage, protect, and process your personal data, we may update our policies, procedures, and practices over time. Any changes to this Privacy Notice will be published on the App and will become effective upon the revised notice’s publication.

### **Collection of Personal Data**

The personal data we collect may vary based on circumstances but generally includes the following information:

Device identifiers (e.g., IDFA, IDFV for Android, GAID for iOS).

Email address.

Network type and operator information (e.g., MAC address).

Device type, version, brand, language, and operating system.

Behavioral usage data within the App.

### **Purposes of Collecting Personal Data**

The personal data we collect is used primarily to enhance user experience, improve the App, and facilitate communication. Your personal data may be used

for the following purposes, or any directly related purposes:

Providing and managing services related to the App's operations.

Complying with legal obligations, such as regulations, judgments, or court orders.

Preventing, detecting, or investigating criminal activities.

Facilitating communication between you and us.

#### Disclosure of Personal Data

We do not sell your personal data. However, we may share your personal data with third parties such as business partners, suppliers, consultants, agencies, governmental bodies, courts, or IT service providers. In such cases, we will require these third parties to comply with this Privacy Notice. We only share personal data when necessary for the activities described in this Notice.

#### Retention of Personal Data

We will store your personal data only for as long as necessary for the purposes for which it was collected, or as required by applicable law.

#### Data Security Measures

We are committed to safeguarding your personal data. We employ various industry-standard security technologies and procedures to protect your data from unauthorized access, use, or disclosure. Our employees are trained on the importance of privacy and data protection. We limit access to personal data to employees who are directly involved in providing services or organizing activities related to your use of the App.

#### Children's Privacy

We understand the importance of protecting children's privacy. We do not knowingly collect or solicit personal data from children under the age of 13 without prior consent from a parent or guardian.
